- 3. If you or your designate choose not to take the trip as awarded, \$750.00 cash prize may be substituted in lieu of any trip or travel voucher.
- 4. Trips to be awarded up to the predetermined dollar amount for each trip, any amount over and above this figure shall be winners responsibility.
- 5. All prizes are tentative and are subject to change due to availability until time of booking.
- 6. Tickets are payable by 12 postdated cheques (dated the 1st of each month 12X\$10.00 = \$120.00) or by cash (\$120.00). 1st cheque March 1, 2018 and continued monthly to February 1, 2019. Make cheques payable to: Kindersley Culture and Recreation Building Fund.
- 7. If any winner has paid by postdated cheques, balance owing must be paid in full before prize is awarded.
